## 1 Changes to the Syllabus and Assessment

## **Syllabus**

There have been no changes to the syllabus objectives.

#### Assessment

Due to the IFoA's announcement that the introduction of Objective-Based Assessment (OBA) for the CB subjects is delayed, the Assessment section of the Study Guide has been updated. It now reads:

At the time of writing it is unknown what the assessment method is for Subject CB1. The IFoA have previously announced that the exam will be changing to Objective-Based Assessment (OBA), but it is unclear when this change will take place. You should therefore monitor communications from the IFoA for further details.

If it is to be an Objective Based Assessment (OBA), the assessment is expected be in the form of a 1 hour 40 minute timed, online objective-based assessment (OBA) examination. This is likely to consist of 60 questions of varying styles. Sample questions illustrating the form of the question types are available on the IFoA website.

If it is to use a traditional (non-OBA) approach, the assessment is expected to consist of one 3 hour 20 minute timed, online examination. This time includes reading time, as well as the time taken for students to download and/or print the question paper.

In this case, students can expect to answer a number of questions of varying marks, using Microsoft Word to construct and type their answers.

## 2 Changes to the Core Reading and ActEd material

#### **Practice Questions**

The practice questions at the end of each chapter have been updated. They now contain a mixture of objective-based assessment (OBA) questions and traditional non-OBA questions. To avoid potential confusion, no questions are labelled as 'exam-style' in the 2025 materials given the lack of certainty about the format of the 2025 exams.

The practice questions in the 2024 materials continue to represent good practice. You should however ignore the 'exam-style' icons.
